





### **Take-Aways**

- In 2024, participants reported the most trash, by Count, removed -- over 21,000 items logged -- weighing over 4 tons. (note: Port Lavaca and Matagorda did not weigh trash.)
- Increased participation from last year 151 participant days and 29 boats.
- New areas cleaned:
  - Powderhorn State Park by HEB employee group. Superintendent Sarah
     Affeldt thanked the group and described plans for Park development.
  - First venture to Gulf Beach thanks to TPWD Wildlife's Patrick Ragusin for his logistical support. The beach is heavily trashed so the crew focused on removing only drink bottles due to the logistics; removed 5350 bottles. Less than 2 miles were attacked. Would like to do it again!
  - o Audubon's Chester Island rookery with Warden Tim Wilkinson.
- 3020 plastic drink bottles were removed from the bay shorelines -- up 50% from last year's 2050 bottles.
- Cumulatively, SABP's Shorelines Cleanups has removed and logged over 57,000, items during its five years.
- Another 10,000 items have been removed / logged by people who leave the bay cleaner—bringing the total trash removed to nearly 68,000 items.
- First time 'Celebrating a Cleaner Bay ' in the evening after Saturday's main event: great shrimp from Cathy's, wine from Gulf Breeze, plus an interesting and informative presentation from Harte Research Institute's Jace Tunnell.
- Thanks to all who participated. The Bays are cleaner and healthier because you care!
- We are not done yet: SABP will participate in a State-wide Cleanup in May with the Gulf of Mexico Trust. The details of our target are being developed. It will likely be focused on a single area. See Executive Director Jay Kleberg and wife Chrissy's documentary 'Chasing the Tide' at <a href="https://chasingthetideseries.com/">https://chasingthetideseries.com/</a> about their recent hike of the Texas Gulf Coast. This statewide initiative will increase awareness of plastic pollution and what can be done.

- If you have pictures that you haven't sent to Brigid, please do so. Will work to get the posted.
- Allan will upload the total in SABP Marine Debris Tracker database.
- Allan and Brigid piloted an app to improve measurement of shorelines cleaned. It was cumbersome. Will suggest modifications to improve effectiveness for next year.
- We plan an anti-litter program for the bay and local communities (Seadrift & POC) it is just starting.
